4. Upon receipt of this signed agreement, Diamond Systems will provide you with the RTLinuxPro runtime environment system. The format will be on a 20GB hard drive.

Developer License Agreement  
for Diamond Systems Computers**

**THIS DEVELOPER LICENSE AGREEMENT (“LICENSE”) IS A LEGAL AGREEMENT BETWEEN YOU AND, IF APPLICABLE, YOUR COMPANY (“LICENSEE”) AND FINITE STATE MACHINE LABS, INC. (“LICENSOR” OR “FSMLABS”) PROVIDING THE TERMS AND CONDITIONS OF LICENSEE’S INSTALLATION AND USE OF THE FSMLABS SOFTWARE IDENTIFIED IN THE ACCOMPANYING DEVELOPER LICENSE AUTHENTICITY CERTIFICATE. PLEASE READ THIS LICENSE CAREFULLY. IF LICENSEE PROCEEDS WITH THE DOWNLOADING, INSTALLATION, AND/OR USE OF THE FSMLABS SOFTWARE LICENSEE IS AGREEING TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THIS LICENSE. IF LICENSEE DOES NOT AGREE TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THIS LICENSE, RETURN THE FSMLABS SOFTWARE TO THE DIAMOND SYSTEMS FOR A REFUND.**

1. **General.** This License is only valid if it is accompanied by a Developer Authenticity Certificate ("Certificate") from FSMLabs. The software and documentation accompanying this License, whether on disk, in read only memory, on any other media or in any other form, and any additional components, bug-fixes, updates, upgrades, or backups provided to Licensee during the term of this License (collectively the "FSMLabs Software") are licensed, not sold, to Licensee by FSMLabs for installation and use only under the terms and conditions of this License, and FSMLabs reserves all rights not expressly granted to Licensee in this License. The FSMLabs Software is protected by patent, copyright, and/or other intellectual property rights of FSMLabs, and the rights granted herein are limited to FSMLabs' intellectual property rights in the FSMLabs Software and do not include any other intellectual property rights. This License does not grant Licensee any rights to the trademarks or service marks of FSMLabs. The FSMLabs Software is licensed, not sold. Licensee owns the media on which the FSMLabs Software is recorded, but FSMLabs retains ownership of the FSMLabs Software itself.
2. **Permitted Developer License Uses and Restrictions.**
  - A) For each Developer License Number specified on the accompanying Certificate, this License grants the right to Licensee to have one individual (“Developer”) install and use, on Licensee’s behalf, one copy of the FSMLabs Software on a single computer or device ("Host") and one copy of the runtime components of the FSMLabs Software, which includes the target file system and binary executables provided as part of the FSMLabs Software or produced on the Host Computer on a single computer or device manufactured by Diamond Systems ("Target"). This License does not allow a copy of the FSMLabs Software to be installed or used simultaneously on more than one Host and one Target, and Licensee is not permitted to make the FSMLabs Software available over a network where it could be used by multiple computers or devices at the same time. Licensee is permitted to make one copy of the FSMLabs Software, including configuration and installation information, for each Host and each Target, in machine-readable form for backup purposes only; provided that the backup copy must include all copyright or other proprietary notices contained on the original. This License does not allow more than one Developer to use the FSMLabs Software at any one time and, for each Developer License Number specified on the accompanying Certificate, no more than five different Developers are permitted to use the FSMLabs Software during any calendar year.
  - B) Except as and only to the extent expressly permitted in this License or by applicable law, Licensee may not copy, decompile, reverse engineer, disassemble, modify, or create derivative works of the FSMLabs Software or any part thereof.
3. **Fees.** In consideration for the rights granted to Licensee herein, Licensee shall pay to FSMLabs the fees in accordance with the terms and conditions of the purchase order or other agreement(s) between the Licensee and FSMLabs that define the purchase and permitted use of the FSMLabs Software, which terms and conditions are incorporated herein by reference.
4. **Transfer.** Licensee may not rent, lease, lend, redistribute, sublicense, or otherwise transfer to any third party the FSMLabs Software or any part thereof, this License, any rights hereunder, or the Certificate without the express written consent of FSMLabs. Any such attempted transfer without the express written consent of FSMLabs shall be void.
5. **Support and Maintenance.** If the Certificate specifies that the License is a “Subscription,” Licensee is entitled to bug-fixes and backups as provided by FSMLabs on its regular update schedule for one year from the effective date identified in the Certificate.

6. **Audit and Security.** Licensee will take reasonable action to restrict and control the installation and use of the FSMLabs Software in accordance with the limitations and restrictions set forth in Section 2 of this License, and to permit access only to Developers authorized to install and use the FSMLabs Software. Licensee will make reasonable efforts to ensure compliance by all Developers authorized to use the FSMLabs Software with this License. Licensee grants to FSMLabs the right to have independent auditors selected by FSMLabs and acceptable to Licensee, such acceptance not to be unreasonably withheld, audit the installation and use of the FSMLabs Software by Licensee to ensure compliance with this License, once per calendar year at any time during regular business hours with three days prior written notice to Licensee.
7. **Termination.** This License is effective until terminated. This License may only be terminated by FSMLabs in the event that Licensee initiates any legal proceedings against FSMLabs. Licensee's rights under this License will terminate automatically without notice from FSMLabs if Licensee fails to comply with any term(s) of this License. Upon termination of this License, Licensee shall cease all use of the FSMLabs Software, and uninstall and destroy all copies, full or partial, of the FSMLabs Software.

If for any reason a court of competent jurisdiction finds any provision of this License, or portion thereof, to be unenforceable, the remainder of this License shall continue in full force and effect.
14. **Third Party Acknowledgements.** Portions of the FSMLabs Software utilize or include third party software and other copyrighted material. Acknowledgements, licensing terms and disclaimers for such material are contained in the "online" electronic documentation for the FSMLabs Software, and Licensee's use of such material is governed by their respective terms.
15. **Complete Agreement.** This License constitutes the entire agreement between the parties with respect to the installation and use of the FSMLabs Software licensed hereunder and supersedes all prior or contemporaneous understandings regarding such subject matter.
